2. ADOPTER'S OBLIGATIONS (In the event that the adoption is for a farm animal, Section 2. A. does not apply.)

A. Neutering. The adopted animal must be neutered/spayed by _____, 200__. Said animal may NOT be used for breeding purposes. Adopter must send CCACO a copy of the spay/neuter certificate signed by the veterinarian who performed the surgery. If this certificate or proof of altering is not received within thirty (30) days of the above date, CCACO reserves the right to terminate this agreement, and the Adopter must return the animal to CCACO.

- B. Return. CCACO retains the right to recover the adopted animal from Adopter if:
- the adoption is not satisfactory to the Adopter.
 - in the CCACO's sole judgment, recovery would be in the best interest of the adopted animal.
 - Adopter fails to comply with the provisions of this agreement.
 - Adopter, at any time, misrepresents to CCACO matters which are material to the welfare of the adopted animal.
 - CCACO is legally obliged to recover the adopted animal from this placement.

C. Transfer of Ownership. The adopted animal may not be transferred to any other person, firm, corporation, or organization without the written consent of CCACO.

D. Training. Under no circumstances will an adopted dog be protection, attack trained or agitated in any manner, or allowed to be used as a guard dog for any agency, firm, corporation, or organization. A dog may be trained as a rescue, guide or service dog, but must be treated as a house pet.

E. Health Program. The adopted animal will be placed on an inoculation program established by the veterinarian of the Adopter. Adopter will provide food, water, shelter, protection, and any medical care needed.

F. Identification. Adopter must place identification (personal ID and the license tag) on said animal, which will remain on the animal at all times. Tattooing and micro-chips are highly recommended, but not required.

G. Loss. If the adopted animal is lost or stolen, the Adopter will notify CCACO immediately.

3. INFORMATION ABOUT THE ADOPTED ANIMAL

As a courtesy, and if available, to Adopter CCACO has furnished Adopter with limited information about the adopted animal. CCACO has no reason to believe this information is false, however, CCACO cannot and does not represent that such information is accurate. Adopter may not and is not relying upon the accuracy of information supplied by CCACO in entering into this agreement. Instead, Adopter has fully and freely examined the adopted animal and has based his/her/its decision to adopt upon Adopter's own evaluation of the animal's character and condition.

4. WARRANTIES AND LIABILITIES

Release. In consideration of the Calhoun County Animal Control Office ("CCACO") transferring the adopted animal to the Adopter, Adopter hereby release and forever discharges CCACO, Calhoun County, Alabama, the Calhoun County Commission, its agents and assigns from any cations, causes of actions, suits, liability, claims, demands, damages or causes of any kind or nature whatsoever, whether presently existing or arising in the future, whether known or unknown, which arise out of or are based upon any fact, matter claim or thing involving the adoption of this animal.

Disclaimer of Uniform Commercial Code Warranties. The adopted animal is furnished to Adopter "As Is", with all faults, and without any representation, guarantee or warranty concerning its performance or condition. Any warranties of merchantability or fitness for a particular purpose are disclaimed by CCACO and waived by Adopter.

5. DONATIONS

Donations are gratefully accepted, however, it is understood that donations are non-refundable.
