

SUMMARY OF MINUTES
CALHOUN COUNTY COMMISSION
NOVEMBER 10, 2010 (SPECIAL DATE)

County Administrator Ken Joiner welcomed guests to the Commissioner's inauguration for the term beginning November 10, 2010, and ending November 11, 2014. Ezell Dickerson gave an invocation. The Honorable Malcolm B. Street, Jr., Presiding Circuit Court Judge, administered the oath of office to Commissioner James A. Dunn, Commissioner Tim Hodges, Commissioner James Eli Henderson, Commissioner J. D. Hess, and Commissioner Rudy Abbott.

Following comments by each Commissioner, Commissioner Dunn called the regular meeting of the Calhoun County Commission to order.

The Commission approved the payment of warrants issued, to-wit:

Commissioner Hess made a motion to adopt the minutes of the previous meeting, followed by a second to the motion from Commissioner Henderson. All Commissioners voted in favor of the motion.

Commissioner Henderson made a motion to adopt the following chairmanship rotation schedule which was presented by Mr. Joiner:

DISTRICT 1 – James A. Dunn	November 10, 2010 - August 28, 2011
DISTRICT 3 – James Eli Henderson	August 29, 2011 - June 16, 2012
DISTRICT 2 – Tim Hodges	June 17, 2012 - April 5, 2013
DISTRICT 4 – J. D. Hess	April 6, 2013 - January 23, 2014
DISTRICT 5 – Rudy Abbott	January 25, 2014 - November 11, 2014

Following a second to the motion by Commissioner Hess, all Commissioners voted in favor of the chairmanship rotation schedule.

Mr. Joiner presented a resolution to establish certain dates for the Commissioners to regularly meet, according to the requirements of the Open Meetings Act. Commissioner Hodges made a motion to adopt the resolution, Commissioner Henderson seconded the motion, and all Commissioners voted in favor of the motion. (RESOLUTION ATTACHED)

Commissioner Abbott made a motion to move the regular commission meeting scheduled for November 23, 2010, which is Thanksgiving, to Wednesday, November 24, 2010, at 10:00 a.m. Commissioner Hess seconded the motion, and the motion carried by a unanimous vote of the Commissioners.

Commissioner Henderson made a motion to adjourn and Commissioner Hess seconded the motion. All Commissioners voted in favor of the motion.

The next meeting of the Calhoun County Commission was announced for Wednesday, November 24, 2010, at 10:00 a.m.
